No money has been collected due to the Senior Center being closed to the public.

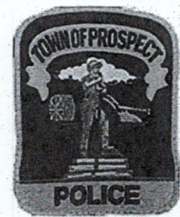

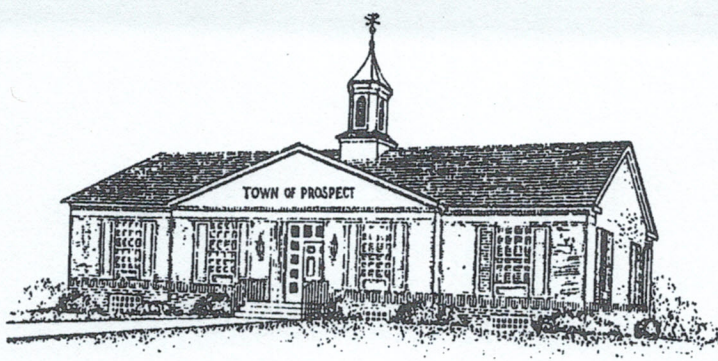
