Copies of the proposed Agreement and Haulers' Rules are on file in the office of the Prospect Town Clerk in the Prospect Town Hall, 36 Center St., Prospect, Connecticut.

**RESOLUTION REGARDING  
ACCEPTABLE RECYCLABLES PROCESSING AGREEMENT**

WHEREAS, Bristol Resource Recovery Facility Operating Committee, a/k/a the Bristol Facility Policy Board ("BRRFOC"), and various Connecticut municipalities including the Town of Prospect are parties to an Inter-Community Agreement ("ICA") dated as of August 1, 1985, as revised by Amendments dated June 13, 1986, December 17, 1987, October 1, 1991, December 1, 1993, and April 15, 2005 (the "Agreement"); and

WHEREAS, BRRFOC and some of the communities that are parties to the ICA, including the Town of Prospect, seek to secure services related to recycling of solid waste generated within the Town of Prospect; and

WHEREAS, in furtherance of its duties under the Inter-Community Agreement, BRRFOC has negotiated an "Acceptable Recyclables Processing Agreement" with Murphy Road Recycling, LLC (the "Agreement"); and

WHEREAS, it is in the interests of the Town of Prospect to enter into the Agreement.

NOW, THEREFORE, the Town of Prospect [legislative body] is duly assembled this 17<sup>th</sup> day of September, 2019 and Mayor Robert Chatfield is authorized to execute and deliver the Agreement on behalf of Town of Prospect in substantially the form dated July 17, 2019 presented to the Town of Prospect Town Council on September 3, 2019, and presented to the [legislative body], and to perform and take such other actions as may be desirable, necessary and proper to accomplish the intent and purpose of the Agreement.
